[®]Vinnolit S 3157/11 is a free-flowing powder produced by suspension copolymerization of vinyl chloride and vinyl acetate.

The product contains about 11 percent vinyl acetate. It is a specialty resin for manufacturing of high-quality rigid films.

[®]Vinnolit S 3157/11 is mainly used as blend component or main component in rigid PVC formulations.

Blends containing °Vinnolit S 3157/11 are used to produce high quality extruded or calendared rigid film. Depending on the addition level, °Vinnolit S 3157/11 improves the thermoforming properties as well as the printability and welding behaviour. The films are therefore easier to glue and laminate.

In other applications, such as flooring, the use of S 3157/11 can optimize and accelerate processing, therefore increase output and quality and increase filler acceptance.
