Ladies and gentlemen,

The REACH-Regulation 1907/2006/EC has been in force since June 1, 2007 and regulates the registration of substances by 2010 / 2013 / 2018 in Europe.

Our PVC-Products "VINNOLIT xxxx" (all types) are polymers, not substances and therefore exempted from registration according to REACH article 2 (9.).

For this reason, you will also not receive a registration number or extended Material Safety Data Sheet with exposure scenarios in the annex. We need no uses from you.

The used monomers for the production of the PVC-Products are already registered with the following Reg.No.:

- Vinyl chloride 01-2119458772-30 and/or
- Vinyl acetate 01-2119471301-50 and/or
- Butyl acrylate 01-2119453155-43 and/or
- Ethyl hexylacrylat 01-2119453158-37 and/or

Because the monomers are far below 0,1% (w/w) in the PVC-Products, it is not necessary to include the Reg.No. for monomers in the Material Safety Data Sheet.

We continuously observe the REACH Candidate List for SVHC (substance of very high concern) and the Restriction List in REACH Annex XVII. There are no SVHC substances in and no restrictions for our PVC-Products. Cadmium, mentioned in REACH Annex XVII 23., and PAH, mentioned in Annex XVII 50 are also no ingredients.
